NOTIFICATION

Sub: Admission to the vacant seats of UG degree programmes for NRIs/Children of NRIs/ candidates sponsored by NRI under NRI quota for the academic year 2025-26.

Ref: 1. Recommendation of the Director of Education, UAS, Mandya dtd 09.10.2025.

2. Approval of the Special Officer, UAS, Mandya dtd 09.10.2025

Applications are invited from eligible candidates for admission to the vacant seats of Undergraduate Degree Programmes at the University of Agricultural Sciences, Mandya under the NRI quota for the academic year 2025–26. This includes NRIs, Children of NRIs, and candidates sponsored by NRIs.

I. Academic Eligibility:

Candidates must have passed a two-year Pre-University Course (10+2) or equivalent examination with:

- A minimum of 50% aggregate marks in Physics, Chemistry, Mathematics, and Biology for all UG programmes.
- Candidates who have studied only Physics, Chemistry, and Biology (with a minimum of 50% aggregate marks) are also eligible for B.Sc. (Hons.) Agriculture, B.Sc. (Forestry), B.Tech. (Biotechnology) and B.Tech. (Food Technology).

II. Number of Seats & Eligibility:

1. 15% of seats over and above the sanctioned intake in each programme are reserved under the NRI quota.
2. Definitions of NRI and NRI-sponsored candidates shall be as per Government of India / Karnataka Examination Authority guidelines.
3. Candidates must have studied in English medium at the 10+2 level or provide proof of English proficiency (e.g., IELTS/TOEFL). This condition is waived for those who studied in English medium.

III. Application and fee:

Application form (PDF) can be downloaded from the University website www.uasmandya.co.in up to **23.10.2025**.

- Submit the filled-in application along with:
 - Attested photocopies of educational documents
 - Notarized affidavits from the sponsorer, parent, and candidate
 - Physical fitness certificate
 - Sponsorer's citizenship, work permit, address proof, VISA & Passport copies
- Application fee: ₹2,000/- via Demand Draft drawn in favour of "The Comptroller, UAS, Mandya – 571405"
- Submit by post to The Registrar, UAS, Mandya, Melukote Road, V.C.Farm, Mandya – 571405 on or before **23.10.2025** during office hours.
- DD must be dated between **09.10.2025** and **23.10.2025**. The University is not responsible for postal delays.

IV. Undertaking:

1. Candidate and parent must submit a notarized undertaking on ₹100/- stamp paper from their place of residence (Annexure-I).
2. Sponsorer must submit a notarized undertaking on ₹100/- stamp paper or equivalent foreign currency (Annexure-II).

NOTE: *Notarized Undertakings submitted after the last date will not be considered.*

V. ORIGINAL DOCUMENTS TO BE PRODUCED DURING ADMISSION:

Selected candidates must produce the following original documents:

- SSLC, PUC (10+2)/Intermediate/12th Marks Cards
- Birth Certificate, Transfer/Migration Certificate
- Medical Fitness Certificate (Govt. Hospital)
- Undertakings (Annexure-I & II)
- Sponsorer's citizenship, work permit, address proof
- Attested copies of Sponsorer's Passport & VISA

VI. Fee Structure

- a) The following is the institutional economic fee in dollars or equivalent Indian rupees per annum to be paid every year during the first semester by the candidate / parent / sponsorer in the form of DD, *drawn in favour of Comptroller, UAS, Mandya, payable at V.C.Farm.*

c) Additional Notes

- Institutional Economic Fee must be paid annually before the academic year begins.

- If a student fails to complete the UG programme within 4 years (8 semesters), 25% of the Institutional Economic Fee shall be paid annually until completion.
- Other applicable fees shall be paid separately.
- Failure to pay the Institutional Economic Fee before the semester registration deadline will result in automatic cancellation of admission.

VIII. CONDITIONS:

1. Admission is governed by Government orders, University regulations, and the approval of the NRI Admission Committee, as issued from time to time.
2. Applications that are incomplete, submitted after the deadline, or without the prescribed fee will not be considered.
3. The number of seats notified is subject to revision in accordance with Central and State Government directives. The University reserves the right to fill or not to fill any or all of the seats notified.
4. Furnishing false information in the application will result in cancellation of admission at any stage.
5. Seat allotment is subject to fulfillment of all eligibility conditions prescribed by the University.
6. Fees paid by the candidate or on behalf of the candidate will not be refunded under any circumstances.
7. Preference in seat allotment will be given to candidates who have studied PCMB subjects in 10+2 or equivalent. Candidates with PCB subjects will be considered thereafter, but must undergo compulsory remedial Mathematics courses to meet academic requirements.
8. Candidates admitted under the NRI quota are not eligible to participate in any other admission process conducted by Farm Universities of Karnataka.
9. If seats in programmes other than B.Sc. (Hons.) Agriculture remain vacant, they may be converted to B.Sc. (Hons.) Agriculture seats at the discretion of UAS, Mandya.
10. Failure to remit the prescribed fees within the stipulated deadline will result in cancellation of admission.
11. Candidates admitted under the NRI quota will not be permitted to transfer between teaching campuses of UAS, Mandya under any circumstances.
12. Allotment will be based on the percentage of marks obtained in PCMB subjects in II PUC/12th standard. In case of a tie:
 - Overall II PUC/12th marks will be considered.
 - If still tied, the candidate's date of birth will be used to determine eligibility.
13. No individual intimation will be sent to candidates regarding admission status.

IX. GENERAL INSTRUCTIONS:

1. After the last date for submission of applications, the list of eligible candidates, merit list, selection list, and final admission deadlines will be published on the University website: www.uasmandya.co.in.
2. Upon receiving the selection letter, candidates must confirm their willingness to join the programme in writing. No change of subject or campus will be entertained thereafter. If a selected candidate fails to join within the stipulated time, the next eligible candidate from the merit list will be considered.
3. The University shall not be held responsible for any unlawful activities involving the candidate during the course of study. The candidate is solely responsible for responding to any legal or disciplinary inquiries.
4. Admission confirmation is subject to verification of original documents, payment of prescribed fees, and fulfillment of all admission requirements.
5. College and course allotment will be based on merit and the options indicated by the applicant, subject to seat availability as per the University's notification.
6. If a candidate voluntarily cancels admission, only the caution deposit will be refunded.

NOTE: Hostel accommodation will be provided subject to availability.
